### What data do we collect?

### How we collect your data?

- Use or view our website via your browser's cookies.

### How will we use your data?

EJ Rehab collects your data so that we can:

- Process your booking.
- Contact you in regards to your treatment plan.
- Email you with special offers .
- Ensure that the treatments we provide are appropriate for you considering your current and previous health conditions and injuries.

### How do we store your data?

EJ Rehab securely stores your data on a secure cloud and within a locked facility.



EJ Rehab will keep your information on file unless you have requested for us to securely dispose of this data.

## What are your data protection rights?

EJ Rehab would like to make sure you are fully aware of all of your data protection rights. Every client is entitled to the following:

**The right to access-** You have the right to request EJ Rehab for copies of your personal data.

**The right to rectification-** You have the right to request that EJ Rehab corrects any information you believe to be inaccurate. You also have the right to request EJ Rehab to complete information you believe is incomplete.

**The right to erasure-** You have the right to request that EJ Rehab erase your personal data, under certain conditions.

**The right to restrict processing-** You have the right to request that EJ Rehab restrict the processing of your personal data, under certain conditions.

**The right to object to processing-** You have the right to object to EJ Rehab's processing of your personal data, under certain conditions.

- **Functionality-** EJ Rehab uses these cookies so that we recognize you on our website and remember your previously selected preferences. A mix of first-party and third-party cookies are used.
- **Advertising-** EJ Rehab uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device and your IP address. EJ Rehab sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
